STRUCTURE, GOVERNANCE AND MANAGEMENT

Statutory Information

The full name of the charity is Devon Community Foundation (hereafter referred to as 'the charity'). The charity's governing instrument is the Memorandum and Articles of Association, as amended by Resolution on 21 November 2006. The charity was incorporated on 12 August 1996 (Registered Company number 3236918) and is registered with the Charity Commission (Registered Charity Number 1057923).

The permanent endowment of Devon Community Foundation is held separately in the Devon Community Foundation Trust, a subsidiary of the Foundation. A Declaration of Trust governs the Devon Community Foundation Trust and its Trustee is the Devon Community Foundation. The charity is also the Trustee of the Tiverton Religious Instruction Fund which was transferred from Devon County Council in January 2009.

Structure, Governance and Management (Cont)

Trustees are normally elected by the members of the organisation at the Annual General Meeting. Occasionally a new Trustee may be elected during the year at a Board Meeting. One third of the Trustees stand down or stand for re-election at each Annual General Meeting. A Trustee's term of office is three years. He/she may be re-elected for a further term.

No Annual General Meeting was actually held during the year under report. The previous AGM had been held on 27 March 2008 and the next was held on 29 April 2009 so will be covered in the next year's Annual Report. The **President** of the charity is Mr Eric Dancer CBE, JP, Lord Lieutenant of Devon. Lord Morley, The Countess of Arran and Sir Ian Amory are **patrons** of the charity. The Foundation publishes information about its Trustees and staff on the Foundation website and this can be accessed through the web address www.devoncf.com

OBJECTIVES AND ACTIVITIES

What the Charity does

Aims

The charity, which is both grant-making and fund-raising, is building permanent capital funds in Devon. The income from this endowment fund is used to make grants to relieve need and counter the effects of disadvantage in the county. The Foundation also manages flow-through grants for a variety of donors from the public, corporate and charitable sectors, as well as for individuals. It is seeking to expand this type of activity in addition to building its own endowment funds.

General Objectives

The charity's stated objectives, as amended by Special Resolution on 21 November 2006 and approved by the Charity Commission, are as follows:

"The Company is to be established for the support or promotion of any charitable purposes for the relief of poverty, the advancement of education (including training for employment or work), the advancement of religion or any other charitable purpose for the benefit of the community in the county of Devon, and, at the Trustees' discretion, the counties of Cornwall, Somerset and Dorset."

Public Benefit

The Foundation has met its objectives regarding Public Benefit through the management of grant programmes supporting voluntary and community groups which help disadvantaged people throughout the county. The full list of 252 grants is set out in note 17 to the accounts. The majority of the funds used for grant making came through programmes managed on behalf of other organisations. Mindful that these funds will not necessarily be available in future years, the Foundation has embarked on an ambitious programme of developing the endowment fund as a means of supporting disadvantaged people in Devon in perpetuity. This programme is supported by the Grassroots Challenge which is described in greater detail later in this report.

Public Benefit (cont)

However, the Trustees regard every aspect of the work and expenditure of the Foundation as being wholly and exclusively aimed at public benefit. The large grant making programme just mentioned is obviously wholly directed at supporting community groups across the whole of historic Devon. And the fund development work is also exclusively aimed at that same purpose because the investment of the growing endowed resources of the Foundation is managed so as to enable income thereby generated to be also distributed to community groups for the benefit of members of the public (and frequently the more deprived sectors of communities) in Devon.

Main Objectives for the Year

There were similar objectives for the financial year 2008-2009 as the previous year:

- To manage a professional and targeted grant-making programme in Devon
- To continue to build the Foundation's endowed funds
- To raise the profile of the Foundation throughout Devon
- To increase partnership working

Strategies for Achieving the Main Objectives for the Year

The strategies in place to deliver these objectives included working with:

- the six other Community Foundations in the South West region,
- the Community Foundation Network (CFN) to secure a Big Lottery grant from the BASIS programme which challenges the Foundation to raise £1m in endowed funds over the period 1 January 2008 to 31 December 2010, securing additional funds for endowment building activity,
- the local media and other voluntary and community sector organisations to raise the profile of the Foundation in the County,
- the Community Council of Devon which currently provides outreach resources within Devon (excluding Plymouth and Torbay) for the Foundation.

Significant Activities Contributing to the Achievement of the Stated Objectives

The major activities in place in 2008-2009 which contributed to the achievement of the above stated objectives included:

- The securing of three separate contracts – called the Grassroots Programme - from the Office for the Third Sector (acting through the Community Development Foundation) for the delivery of both a programme of grant-making and an endowment building challenge throughout “historic Devon” which extends to what is now the administrative County of Devon and the unitary authority areas of Plymouth and Torbay.

Significant Activities (cont)

- The development and strengthening of the relationship with The Drake Foundation which has become the grant decision-making arm and the Grassroots fund development arm of the Foundation within the City of Plymouth.
- Further extensive development of fund development work, which yielded real benefits in this year (to which reference will be made elsewhere.)
- Participating in wider voluntary sector initiatives such as the Devon Children's Trust, Devon Forum and the Devon Consortium.

Policies

The Trustees have approved a wide range of policies and procedures which cover all aspects of the charity's work and are monitored, reviewed and updated as appropriate.

Staff

During the year the charity employed four full-time members of staff, and three part time staff. In the latter part of the year the former Director, Melanie McLoughlin, retired. She made a significant contribution over eight years in the development of the Foundation from its very early formative stages through to it being a progressive and growing deliverer of major grants. Her work also enabled the endowment building work of the Foundation to take a significant leap forward. Following her retirement the staff have been ably led by Kathy Beechen, as Acting Director, and a new Chief Executive has been appointed with effect from 1 September 2009.

ACHIEVEMENTS AND PERFORMANCE

Key landmarks of the year included the following:

- The involvement in a visit by His Royal Highness, Prince Edward, to Ilfracombe in November 2008 where he met representatives of projects funded by the charity and heard a presentation by the Acting Director.
- Being awarded three contracts for delivery of the Grassroots grant-making and endowment building challenge across historic Devon.
- Achieving all the performance targets by 31 March 2009 to build the endowment and in order to draw down Grassroots matched funding
- The growth of the endowment fund by £642,653. This is permanently endowed and only the yield can be used for making grants
- A major profile and fund development event held at the Royal Torquay Yacht Club
- The continued support from the Viscount Amory's Charitable Trust for our work in the area of fund development.
- Grants of £31,250 from Exeter City Council to continue the Exeter Positive Steps Fund into 2009-2010.

- New Named Funds were established by individuals and companies.
- The cementing of relationships and co-operation with the Drake Foundation in Plymouth, which supports the development of the Plymouth Grassroots Fund and advises on the distribution of Grassroots Grants.
- The transfer of assets from the Trustees of the North Devon & West Somerset Relief Fund to the Devon and Somerset Community Foundations.
- Extensive work was undertaken with the Trustees of the Devonian Trust which culminated in the transfer of all the assets of that Trust to this Foundation around the very end of the financial year. The full impact of this work will be shown in next year's annual report because most transfers took place a few days after 31 March 2009. This Foundation will now administer the Devonian Trust assets as a named fund within the Foundation.
- The Foundation's Acting Director continued to serve as one of two voluntary sector representatives on the Board of the Devon Children's Trust.

In terms of performance achieved against objectives set for the year, the Foundation set four key objectives for 2008-2009, against which it achieved the following :

During the course of the year, the Foundation awarded grants totalling £548,170 (2007/08: £1,229,562) to 252 projects throughout the County (a decrease of 55.4%). Details of all grants awarded are available on the Foundation's website www.devoncf.com, with grants of £1,000, or more, detailed at the end of these accounts (note 17). The significant decrease in grant making was due to the completion of the Local Network Fund and Global Grants programmes at 31 March 2008. The start of the Grassroots programme, which had a significantly smaller allocation of flow through grant making, was delayed until July 2008.

John Heathcoat & Co continued to provide office accommodation for the Foundation at their premises in Tiverton. First Great Western provided vouchers for free travel to London meetings for Foundation staff, and meeting rooms were provided by Ashfords, the Midas Group, Devon County Council, Exeter City Council and John Heathcoat and Co. Hooper and Wollen sponsored the event held at the Torquay Yacht Club.

The Foundation benefits greatly from liaison with many local voluntary groups. Practical advice and support is provided by the Community Foundation Network and in particular by the neighbouring Community Foundations in the South West Region. This is a product of the developing relationship fostered by the Big Lottery BASIS and South West Regional Development Agency grants.

Reserves policy

The Foundation believes that it is appropriate to maintain a reserve of unrestricted funds in order to ensure:

- The smooth operation of the Foundation in the event of long-term illness of a member of staff
- The continuation of activities in the short term if sources of flow-through grant-making ceased or diminished
- The financing of obligations, residual liabilities and redundancies should the Foundation cease to operate

To this end the Foundation has retained a sum of £60,000 in a designated reserve fund which represents six months of core administration and management costs.

The financial position of the Foundation is reviewed on a regular basis by Trustees informally and by the Management & Governance Committee which reports to the full Board of Trustees on a quarterly basis. The level of financial reserves in the designated fund will be adjusted appropriately. It is planned to increase this reserve as the scale of operation of the Foundation grows. Unrestricted funds, which are the free reserves of the charity, amounted to £132,563 at 31 March 2009 (2007/08: £111,957). Within this total undesignated funds amount to £68,390 (see note 12 to the accounts).

FINANCIAL REVIEW:

Risk management

The Trustees reviewed the major risks to which the charity is exposed. The need for ongoing work in this area has been identified and is current as this report is written. Nevertheless, the Trustees are confident that review systems have been established to mitigate identified risks. As part of the Foundation's management of risk, Mr Chris Hill, a Chartered Accountant, continued to serve on the board.

Comments on the Accounts

The Foundation has received income in the period totalling £1,411,089 of which £710,742 represents restricted funds for grant making and administration and £620,699 represents endowment growth. It also benefits from a grant from the South West Regional Development Agency (SWERDA), which was made to the seven Community Foundations in the region with the aim of bringing them all up to a common standard of delivery – a standard which Devon Community Foundation was the first to reach. Devon received a total of £9,723 in 2008-2009 which has been used to provide training, fund events and develop collaborative working in the South West Community Foundations.

The three year grant from the Big Lottery BASIS programme, which was awarded in December 2007, was applied for by the Community Foundation Network on behalf of the seven Community Foundations in the South West region. The grant provides core funding for fund development work and carries with it a challenge to raise an aggregate of £7 million in endowed funds across the region: £1m per Foundation, over the three year life of the grant. The quarterly reports submitted have demonstrated that the Foundation is on target to achieve this challenge.

In July 2008 the charity was successful in its bid to manage the three Grassroots Grants contracts across Devon. In addition to a programme of grant funding for small voluntary and community groups, Grassroots Grants carries a £1.1m challenge to raise endowment funds. The purpose is to increase the donor base and to encourage philanthropy in the County in order to provide a perpetual source of income from which to make grants to support the local voluntary community. Accordingly the charity has significantly increased its fund development activity with support from the SWERDA and BASIS grants described above.

It is confirmed that the accounts comply with current statutory requirements, with the Statement of Recommended Practice for charity accounting and with the requirements of the Memorandum and Articles of Association.

Auditors

Francis Clark has indicated their willingness to continue in office and a resolution to re-appoint them was approved at the Annual General Meeting held on 29 April 2009.

Principal Funding Sources

Principal sources of income in 2008-2009 were:

- Office for the Third Sector (Grassroots)
- Exeter City Council (Exeter Positive Steps)
- Devon County Council
- Comic Relief (Sport Relief)
- South West Regional Development Agency
- Viscount Amory's Charitable Trust
- Anonymous donor
- Wales & West Utilities
- Clare Milne Trust

These funds have provided income to support the Foundation's grant-making activity and associated management fees have supported the Foundation's core costs. Publicity for grants made has helped to raise the profile of the Foundation in the local community. In relation to fund development, grants have been secured from the Big Lottery BASIS programme, Viscount Amory's Charitable Trust and from private donors.

PLANS FOR FUTURE PERIODS:

In the report last year the Trustees recorded that the Local Network Fund for Children and Young People and two European Social Fund Objective 3 Global Grants programmes were due to come to an end. That had been a source of concern. However, the bid to manage the Grassroots Programme was successful and this secures the core activity of the charity until 31 March 2011.

Applications to manage other funds are being negotiated on behalf of the charity by the Community Foundation Network (CFN). The quality accreditation achieved in 2006 enables the CFN to proceed with confidence that Community Foundations can deliver a high standard of service to donors and funders. In the next eighteen months it is expected that the quality accreditation will be renewed.

Work will continue on the transfer of dormant and inactive trusts.

FUNDS HELD AS CUSTODIAN ON BEHALF OF OTHERS:

The Foundation currently has no funds which are held as Custodian Trustee on behalf of others.

We have audited the financial statements of Devon Community Foundation for the year ended 31 March 2009, which comprise the Statement of Financial Activities, the Balance Sheet, the Income and Expenditure Account, the Statement of Total Recognised Gains and Losses and related notes. These financial statements have been prepared under the accounting policies set out therein.

1. Accounting Policies

Basis of preparation

The financial statements have been prepared under the historical cost convention, as modified by the revaluation of investments, and in accordance with applicable accounting standards. In preparing the financial statements the charity follows best practice as laid down in the Statement of Recommended Practice: Accounting and Reporting by Charities issued in March 2005.

Incoming resources

Donations are included on a cash received basis.

Grants received are credited to revenue at the time the charity becomes entitled to the income. Where a corresponding obligation to make a grant arises, provision is made at the same time. Grants are allocated to restricted funds where the donor has specified a particular purpose for the grant.

Resources expended

Expenditure is recognised on an accruals basis when a liability is incurred. Grant payments are recognised when a constructive obligation arises that results in the payment being unavoidable.

Costs of generating funds are those associated with generating voluntary income.

Charitable expenditure comprises those costs incurred by the charity in carrying out its grant-making activities.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include costs linked to the strategic management of the charity.

Expenditure is allocated between the above headings in the Statement of Financial Activities on a direct basis apart from staff costs, which are allocated based upon the amount of time staff work on each area.

Taxation

Devon Community Foundation has charitable status and uses its funds for charitable purposes. Therefore, no taxation is included in these financial statements. The charity is not registered for Value Added Tax, and expenditure therefore includes VAT where appropriate.

Tangible fixed assets and depreciation

All assets costing more than £500 are capitalised, and are included at cost. Depreciation is provided to write off the cost of tangible fixed assets by equal instalments over their estimated useful economic lives as follows:

Computer and office equipment - straight line over 3 years.

Funds

- Unrestricted funds represent incoming resources receivable or generated for the objects of the charity without further specific purpose and are available for use at the discretion of the Trustees (see note 12).
- The charity has a number of restricted funds to account for situations where a donor or grant-making body requires that a donation or grant must be spent on a particular purpose (see note 13).
- Permanent endowment funds represent funds where there is no power to convert capital into income (see note 14).

Administration and Governance costs amounting to £108,352 were charged to restricted funds, representing the portion of costs funded by the Local Network Fund (£29,675), Exeter Positive Steps Fund (£5,769) Devon Step Up Fund (£6,092) and Grassroots Devon, Plymouth and Torbay combined (£66,816).

Grassroots Grants is an Office of the Third Sector programme managed by the Community Development Foundation. The Foundation operates funds separately for the three top tier Local Authority Areas; Devon, Plymouth and Torbay. Grants of between £250 and £5,000 are available to established small voluntary/community groups. The programme will run until March 2011. Interest of £1,283 for Devon, £90 for Plymouth and £230 for Torbay is carried forward to be added to the grant allocation for 2009-10.

The **Local Network Fund** grant from the Department for Children, Schools and Families supported projects for disadvantaged children and young people. The programme ceased on 31 March 2008 and the residual funds were used to finish any administrative work remaining until 31 July 2008

Sport Relief Grants are for organisations in Devon using sport to tackle social exclusion. This programme was part of Comic Relief and finished on 31 December 2008.

The **Exeter Positive Steps** Fund and **Devon Step Up** Fund were European Social Fund Objective 3 Global Grants programmes for projects based in Exeter and the rural districts of Devon, respectively, which offer unemployed people the opportunity to become involved in projects to help them on the road to work. ESF support for both of these programmes ended in June 2008 and the residual funds were used to complete the evaluation and administrative work. However Exeter City Council, Friends Provident and a private donor have contributed new funds to ensure that the programme will continue in Exeter over the next two years and £52,201 is carried forward for grant making. **Donor advised** grants of £35,000 were also awarded in 2008-09 to projects in Exeter.

Assets from the former North Devon and West Somerset Flood Relief Fund were transferred proportionately to Devon Community Foundation and Somerset Community Foundation in May 2008. £120,180 is now held as permanent endowment and the yield from the fund is available to the **North Devon Relief Fund** for grants to groups in North Devon. The restricted fund shows that £3,001 is carried forward 2009-10.

The **Clare Milne Trust Fund** awarded £4,500 to the Foundation in September 2008 to distribute as small grants to groups working locally with people who have a disability. £1,500 is carried forward to 2009-10. **Wales & West Utilities** donated £2,250 for distribution as small grants and had also contributed to the Endowment Fund. £250 is carried forward to 2009-10.

The **Small Grants and Rural Fund** grant programmes are funded through the interest received from the endowment capital. £2,120 and £1,144 respectively are carried forward to 2009-10.

The **Mildmay White Family** and **Ray Miles Funds** have been created this year as named Funds held in the endowment fund. The interest from these funds will be available for grant making in 2009-10 and the fundholders may advise the Foundation on the grants to be awarded.

Grants totalling £9,723 were received through a **South West Regional Development Agency** programme to develop the Foundation. This programme finished on 30 June 2009.

Grants were received from private donors specifically to support the work of the Development Manager and Director on strategies to help build the Foundation's endowment funds. In addition a Big Lottery Basis grant of £21,756 a year, for three years, helps with the development costs. The Basis programme also supports the other six community foundations in the South West.

In 2007-08 the **Aim** Foundation awarded a total grant of £50,000 of which £25,000 was restricted to match donations to the Endowment Fund. £22,500 was brought forward at the beginning of 2008-09 and this has now been transferred to the Endowment Fund.
